Upon our receipt of your signed acceptance of these terms and conditions for occupancy, you are granted permission to install cable facilities on or within Outside Plant Structures owned by Cincinnati Bell Telephone Company (CBT) at the locations described in the following *Inventory of Accommodations*. This permission to proceed is conditional on the following:

1. All of the Licensee's installation work is to be performed by a CBT certified contractor.
2. Work operations and facility installations will comply with all industry safety and technical standards, including those published by OSHA, the National Electrical Code, the National Electrical Safety Code, and the Bellcore Blue Book - Manual of Construction Procedures; and with all state and local requirements, such as building codes, roadway excavation permits and right-of-way usage permits.
3. Installation subject to a post-installation field inspection, the cost of which is fully billable to Licensee.
4. At CBT's discretion, Licensee is responsible for any cost required to correct any immediate or future deficiency of Licensee's installation; or to correct any impairment, limitation or conflict with CBT's ability to make full use of its structures in the future.
5. To the extent permitted by law, including but not limited to section 177 of the Kentucky Constitution, Licensee indemnifies and saves CBT harmless against any damage or loss that may result from its installation, and from any claims against CBT from other parties resulting from the presence of Licensee's facilities.
6. This Accommodation is not assignable, and is limited to the facility described.

Upon satisfaction of these Terms by both Parties and payment by Licensor of all charges presented by CBT, this Conditional Permit will be made an integral part of a final Administrative Agreement for the occupancy described.
